



Kõigi õiguste ja kohustuste üleandmine, mis on seotud mitteelukindlustuse RAC likvideerimisportfellidega

See dokument on avaldatud, kohaldades Eesti Vabariigi kindlustustegevuse seaduse artiklit 135.

AXA BELGIUM (Belgia õiguse alusel asutatud aktsiaselts, mille peakontor asub aadressil Place du Trône 1, 1000 Brüssel, registreeritud pangas Carrefour des Entreprises numbri 0404.483.367 all, Belgia keskpanga poolt numbri 0039 all volitatud kindlustusselts) loovutas äriühingule PORTMAN INSURANCE SE (Prantsuse õiguse alusel asutatud Euroopa äriühing, mille peakontor asub aadressil 61 rue Mstislav Rostropovitch, 75017 Pariis, Prantsusmaa, registreeritud Pariisi äriregistris numbri 834 297 749 all ja kinnitatud usaldatavusnõuete täitmise järelevalve ja otsustamisvolitustega asutuse juures) kõik õigused ja kohustused, mis kuuluvad äriühingule AXA BELGIUM mitteelukindlustuse likvideerimisportfellis, mille AXA BELGIUM ja PORTMAN INSURANCE SE on tuvastanud nime „RAC“ all ja mille teatavad riskid asuvad Eestis.

Selle üleandmise kiitis heaks Belgia keskpank 2. oktoobril 2018. See üleandmine jõustub 4. oktoobril 2018 kell 00:00.

Transfer of all rights and obligations in respect of the Non-Life insurance contracts of the portfolio in run-off referred to as RAC

The present communication is published in application of article 135 of the Estonian Insurance Act.

AXA BELGIUM (public limited company under Belgian law, with registered office at 1 Place du Trône in 1000 Brussels, registered with the Cross-reference Database of Companies (CBE/KBO) as number 0404.483.367, insurance company licensed by the National Bank of Belgium as number 0039) is intending to transfer to PORTMAN INSURANCE SE (European company under French law, with registered office at 61 rue Mstislav Rostropovitch in 75017 Paris, France, registered with the Paris Trade and Companies Register as number 834 297 749 RCS Paris, insurance company licensed by the French Prudential Supervision and Resolution Authority) all rights and obligations held by AXA BELGIUM in the Non-Life insurance contract portfolio in run-off, identified by AXA BELGIUM and by PORTMAN INSURANCE SE under the name "RAC", of which some risks are situated in Estonia.

This transfer was authorised by the National Bank of Belgium on 2 October 2018. The said transfer took effect on 4 October 2018 at 00.00 hours.
